Good to speak to you earlier this morning.

Please find attached the latest design plan for the space outside All Saints Church as well as a Powerpoint slide defining where we believe the land and highway boundaries are.

Our original investigations meant we initially thought the highway boundary extended to the gulley line (the light blue line in the Powerpoint), but following a revised boundaries plan we now believe it is further out at the solid red line, which I presume accommodates access to the lighting columns, whereas the title plan for the church extends to encompass all of the area within our proposed project.

As mentioned, we would like to discuss how best to approach this so we can still improve the area outside the church so it is more accessible, tidy and pleasant.
