Our Commitments

In accordance with the Church of England Safeguarding Policy, **St Bartholomew's Church, Egdean** is committed to:

- Promoting a safer environment and culture
 - Safely recruiting and supporting all those with any responsibility for children, young people and vulnerable adults
 - Responding promptly to every safeguarding concern or allegation
 - Caring pastorally for victims/survivors of abuse and all others affected
 - Caring pastorally for those who are the subject of concerns or allegations
 - Responding appropriately to those who may pose a present risk to others
- We recognise that safeguarding is everyone's responsibility.

We are committed to implementing all safeguarding policies and practice guidance issued by the House of Bishops.

The Parish Will:

- Create a safe and caring place for all
- Appoint a Parish Safeguarding Officer (PSO)
- Safely recruit, train and support all those with safeguarding responsibilities
- Use the Disclosure and Barring Service appropriately
- Ensure appropriate insurance cover for all activities
- Display safeguarding contact details clearly in church and online
- Listen to and take seriously all who disclose abuse
- Notify the Diocesan Safeguarding Adviser (DSA) and statutory agencies immediately when concerns arise
- Co-operate fully with statutory agencies
- Offer support to victims/survivors of abuse
- Respond appropriately to those who have committed sexual offences who wish to join our fellowship
- Care for and monitor any member of the church community who may pose a risk
- Ensure health and safety policies and risk assessments are in place and reviewed annually
- Review this policy, procedures and practice at least annually
